The victim, HMB Electronics LLC, was recently contacted by a company regarding a quote allegedly made by HMB Electronics Limited. The initial quote was made on May 17, 2018, via HKInventory in response to a requirement posting by the Buyer. All communication through HKInventory was in the name Kimi Lin, [sales@hmbele.com](mailto:sales@hmbele.com). The Buyer indicated on May 18th that the price was too high.

On May 22, 2018, the Buyer received an email from [sales@hmbele.com](mailto:sales@hmbele.com) regarding this same quotation. However, the email contained the following signature:

The Buyer decided to accept the quotation on May 23, 2018 and requested lead time, payment, and shipping information. HMB Electronics Limited responded, again using HMB Electronics LLC's email signature, with a one-week lead time and payment of wire transfer in advance. Prior to placing the PO, the potential Buyer contacted HMB Electronics LLC and learned the quotation did not come from them.

The website, [www.hmbele.com](http://www.hmbele.com), is parked free by GoDaddy. It was privately registered on April 10, 2018.

HMB Electronics Limited has a Hong Kong business license. It was registered on January 24, 2018 and has a CR number of 2646002.
